(the "Author")

WHEREAS the Author has created a manuscript titled as above (the "Work") and wishes to publish it in PULSE;

AND WHEREAS PULSE wishes to publish the Work subject to the terms and conditions set forth in this Agreement;

The parties agree to the following terms:

1. COPYRIGHT OWNERSHIP AND LICENSE GRANT

1.1 The Author retains copyright ownership of the Work submitted for publication in PULSE.

1.2 The Author hereby grants to PULSE:

- a) The exclusive right of first publication of the Work, in whole or in part, in print and electronic format;
- b) A non-exclusive, worldwide, royalty-free license to publish, reproduce, distribute, display, and store the Work in all forms, formats, and media now known or hereafter developed, including print, electronic, and digital forms;
- c) The right to edit or make editorial changes to the Work and to publish the Work under a Creative Commons Attribution License (CC BY 4.0) or subsequent version thereof;
- d) The right to use the Author's name and likeness in association with the Work and derivatives thereof.

1.3 The Author agrees that the Work will be published and distributed under the terms of the Creative Commons Attribution License 4.0 International (CC BY 4.0), which permits others to share, adapt, and build upon the Work for any purpose, provided appropriate attribution is given to the Author and the initial publication in PULSE.

2. AUTHOR'S REPRESENTATIONS AND WARRANTIES

2.1 The Author represents and warrants that:

- a) The Work is original and has not been previously published in any other journal or publication;
- b) The Author is the sole creator and owner of the Work, or has obtained written permission from any co-authors to enter into this Agreement on their behalf;
- c) The Work does not infringe upon any copyright, proprietary, or personal right of any third party;
- d) The Work contains no material that is defamatory, violates any right of privacy, or is otherwise contrary to law;
- e) The Author has obtained permission to reproduce any material in the Work that is owned by third parties, including images, tables, or extended quotations;
- f) All statements asserted as facts in the Work are either true or based on reasonable research;
- g) The Work contains no material that is unlawful, in violation of any applicable regulations, or that encourages conduct that would constitute a criminal offense.

2.2 The Author shall indemnify and hold PULSE harmless against any claims, actions, or damages resulting from breach of any of the warranties in this section.

3. AUTHOR'S RETAINED RIGHTS

3.1 The Author retains the following rights:

- a) The right to use the Work in teaching or portfolio materials at the Author's institution;
- b) The right to present the Work at academic conferences or meetings;
- c) The right to include the Work in educational uses;
- d) The right to include the Work in future collections of the Author's work or in theses and dissertations;
- e) The right to post the published version of the Work on the Author's personal website or institutional repository, with appropriate attribution to PULSE;
- f) The right to reuse portions or extracts from the Work in other works created by the Author, with appropriate citation of the original publication in PULSE.

3.2 In all cases of reuse or distribution, the Author must include a citation to the original publication in PULSE and indicate that the Work is subject to a Creative Commons license.

4. PUBLICATION PROCESS

4.1 PULSE agrees to publish the Work, subject to:

- a) Successful completion of PULSE's peer review process;
- b) Final acceptance by PULSE's editorial team;

c) Adherence to PULSE's publication standards and policies.

4.2 PULSE reserves the right to make editorial changes to ensure clarity, conformity with style, and publication standards. Substantive changes will be subject to approval by the Author.

4.3 PULSE shall provide the Author with proofs of the Work prior to publication. The Author agrees to review these proofs promptly and return them with any necessary corrections.

5. ETHICAL STANDARDS

5.1 The Author confirms that any research involving human subjects complies with applicable ethical standards and has received appropriate institutional approval.

5.2 The Author agrees to disclose all sources of funding and any potential conflicts of interest related to the Work.

5.3 The Author acknowledges that PULSE adheres to guidelines established by the Committee on Publication Ethics (COPE) and similar bodies regarding research and publication ethics.

6. GENERAL PROVISIONS

6.1 This Agreement constitutes the entire agreement between the parties concerning its subject matter and supersedes all prior agreements.

6.2 This Agreement shall be governed by and construed in accordance with the laws of Singapore. Any disputes arising under this Agreement shall be subject to the exclusive jurisdiction of the courts of Singapore.

6.3 If any provision of this Agreement is found to be unlawful or unenforceable, the remainder of the Agreement shall remain in effect.

6.4 This Agreement may not be modified except by written instrument signed by both parties.

6.5 The rights and obligations in this Agreement will be binding on the heirs, executors, administrators, and permitted assigns of the Author.
